Dear Colleagues,

You are kindly invited to attend the 30<sup>th</sup> session of the SIO, which, as previously announced, will take place during the ICA Congress in Vienna. This SIO meeting is scheduled for 23<sup>rd</sup> August 2004, from 9.30 a.m. to 6 p.m. Information about the meeting room will be available when you arrive at the Congress reception and on the Congress web site before the end of June 2004; this web site already now provides information about the professional programme as well as other issues relating to the Congress: http://www.wien2004.ica.org/

The SIO is co-organizing with ICA's Working Group on Archives and Human Rights two sessions at the ICA Congress, a Round Table on the theme "Archives of international organizations and human rights" and a session on the theme "Archives and Human Rights Violations". Both sessions are scheduled on Wednesday afternoon, 25<sup>th</sup> August 2004 in Hall E2, from 14:30 - 15:45 and 16:15 – 17:30, respectively.

I hope you will be able to attend these sessions. They are both highly relevant for international organizations; the Round Table panel is in fact almost exclusively composed of SIO members.

The hosts and organizers strongly encourage you to <u>register</u> to the ICA Congress before the end of May 2004. The ICA Executive Committee has agreed on a draft Constitution to be submitted to the ICA General Assembly in Vienna. This new text is now being distributed to ICA members. The revised Constitution will, if approved by the General Assembly, lead to a situation where most sections, probably including the SIO, will be represented by their chairs in the ICA Executive Committee. This is a positive result of suggestions made by the SIO and other sections.
