

## SKR sets out to meet the challenges of a changing world

**Faith traditions around the world in the twenty first century will have to coexist and interact with local communities and nations facing increasing levels of instability and social, technological, economic and political change. The archives of faith communities will inevitably reflect these changes. With a view to assisting archives and archivists of these communities around the world to cope with change and new challenges, the Section of Archives Churches and Religious Denominations (SKR) has begun the process of refreshing and re-shaping itself with the aim of re-engaging with faith groups globally.**

The Steering Committee met in March 2012 in Edinburgh, Scotland, to begin the exciting task of building on the desire for change to tackle the challenges of a fast moving world that first emerged at the SKR meeting held in Rome in November 2009. On 14 March 2012, at the Scottish Catholic Archives situated amongst the Georgian cobbled streets and historic town houses of Edinburgh's New Town area, the Steering Committee set out an agenda for SKR. The minutes of the meeting are available from the Newsletter editor or through the SKR pages on the ICA website.

The key actions from the meeting were as follows:

### A new name – from SKR to SAFT

The Section was given the title 'Section for Archives of Churches and Religious Denominations' when it was established in 1995 at its first ever meeting in Prague. As this title is now seventeen years old, the Steering Committee decided the time was right to change the name of the Section to better reflect a more inclusive approach to the diversity of faith traditions in the world. The new title Section for Archives of Faith

Traditions (SAFT) has been proposed for ratification at the ICA Congress in Brisbane in August. The new title will allow the Section to extend its global reach to encompass faith groups in all their many forms – from the major faith traditions Buddhism, Christianity, Hinduism, Islam, Judaism and Sikhism, through to less well known ones, such as Baha'i, Jainism, the Rastafari movement and Shintoism.

### SAFT Bookmark

If the new name is approved in Brisbane, there are plans for the Section to design and distribute a bookmark in time for the 2013 ICA annual meeting. The bookmark will ask people to translate the new title into their language by asking, "How would you say?" and will include the following titles:

- Section for Archives of Faith Traditions (English)
- Section des archives des traditions de foi (French)
- La seccion de archivos de tradiciones de fe (Spanish)

Translations in other languages are welcome; please send them to the Newsletter editor. ■

## What we want to achieve 2012-2016

The Steering Committee considered a new overall mission statement for the Section was required, together with fresh goals and objectives.

The following broad mission statement was developed:

Advocate for archival management based on professional practices and standards, including access and protection of cultural resources critical to our understanding of archives of faith traditions.

The Section's goals were considered in depth and revised to cover the following areas, reflecting the general objectives of ICA as set out in article III of the constitution:

- **promoting** professional and scholarly co-operation and communication between the archives of faith traditions in order to preserve heritage and promote access;
- **assisting** in the basic and continuing professional training of staff in charge of the archives of faith traditions;
- **developing** and disseminating standards and ethics for the preservation, arrangement and description of the archival heritage of faith traditions.



## What we want to achieve 2012-2016 (continued)

The Section's objectives were defined as:

- increase and diversify membership of the Section amongst faith traditions;
- enhance communication and exchange information between archivists of faith traditions through face to face meetings and conferences, print and social media;
- encourage the establishment of sustainable archives of faith traditions around the world;
- facilitate knowledge of guidelines for the management of archival holdings;
- encourage access to collections around the world and support the study of faith traditions in the spirit of mutual tolerance;
- represent the views and interests of archivists of faith traditions, especially in the programmes of the ICA.

These goals and objectives reflect the ambitions of the 2009 SKR Committee meeting in Rome where advocacy was seen as a major component of the Section's work, an approach that the meeting in Edinburgh was keen to support, promote and strengthen. ■

- Ian Wakeling, The Children's Society (Church of England Children's Society), vice-chair


