Commemoration for Cristina Bianchi

It was with great sorrow and disbelief we received the message that our dear colleague and friend, Cristina Bianchi, had passed away October 26, 2017. From one instant to another, at the blink of an eye, her life was over. Reminding the rest of us of how fragile we all are, how important it is to live life to its fullest. Cristina, who had turned 60 this year, was always full of life, she embraced it! She loved to travel, spoke several languages and had such a genuine interest in all that she encountered, be it people or places or food or culture. Cristina meant so much to so many people in our community within the International Council on Archives (ICA), as a professional, as an archivist, and as a person. She had such a beautiful ambiance about her. She was knowledgeable, kind, caring, giving and also never afraid of speaking her mind. She was quite witty, the kind of quiet wit that needs to sink in and that you would chuckle when remembering hours later. She also had the best laugh and wasn't stingy about spreading it around. I first met Cristina when I joined the ICA Section of Professional Associations (SPA) in Brisbane in 2012. We were on the steering committee together for four years and had started on a new four-year term together in Seoul in 2016. Cristina representing Switzerland, I representing Norway. I was so happy that she continued on because of all her knowledge and experience, both within archives and records management, but also because of her language skills and her passion and drive as an ICA volunteer. Just two weeks ago we met via Skype discussing a workshop we were going to do together during the ICA conference in Mexico City late November. That I am now writing an obituary is so tragic, sad, and unreal. Cristina has left massive footprints in all of us who knew her. Not from stomping, but from walking humbly. And oozing of wisdom, kindness and joy. I will miss Cristina immensely, both as an archivist, a fellow ICA volunteer, a travel companion and as a friend. And I know that there are people in all corners of the world, feeling the same way. In China, Chile, Senegal, Poland, Spain, North America, the Netherlands, Germany, France and Israel. And many more. We send our thoughts to Cristina's family in this time of grief and promise that she will live on forever in our minds and happy memories. Rest in peace, Cristina Bianchi.

Workshops:

- Together with Emilie Leumas, Vilde gave a training course on records management for about 70 Tanzanian archivists during the mid-year meeting of the Executive Board (EB), PCOM and section chairs in Tanzania in May.
- Some of the Steering Committee of SPA (Vilde, Bert, Joan, Becky) and further colleagues (Sylvie Clair, Marianne Hoiklev Tengs) organized a “hands-on”-workshop on elevator pitches during the ICA conference in Mexico City. Archivists and records managers took part at a training how to place archival and records management issues with the right words for their audience, enthusiasm and in only few minutes. The SPA Steering Committee will work out a toolkit for elevator pitches and will publish it on the website, so it can be used for further trainings.

3 Activities of the SPA Steering Committee

Who is member of SPA?

SPA currently has 74 member associations. As SPA chair, Vilde is asked to approve any new associations that wish to join SPA. When an association pays its dues as a “category B” member of ICA, it is not considered a member until Vilde affirms that it is a qualified professional association.

SPA Film Festival

It was decided to hold the second SPA film festival in 2019 at the ICA annual meeting in Edinburgh, Scotland. The work on that project will begin during the SPA meeting in Berlin.

Africa Programme

At the previous SPA meeting there was discussion about what SPA could do to advance the goals of ICA’s Africa Programme and to support the African professional associations. Before we can cooperate with African associations we have to have basic information about associations in Africa and contact person. Therefore: First, we will make a list with African SPA members. Further, we will check with our own country association to see if there are already projects in place which support African Archives. And we plan a workshop for/with the African associations at the ICA annual meeting in Cameroon 2018. Our activities for the Africa programme will be a good opportunity to promote the cooperation with other units of ICA, which seems to us a good profit for everyone in the ICA.

SPA Directory of member and non-member associations

There was discussion about how to proceed on this complex project, e.g. checking the mail addresses and websites-links currently on the SPA website. Since it is a general ICA issue we will cooperate with

the Secretariat office in Paris to get an updated list of member associations. We must decide what information should be included in the association directory. What do associations need from an association directory?

SPA Communications

Newsletter

It is our intention to change to a blog format now that ICA has a new association management platform. But many ICA groups want to do a blog and we do not yet know when the blog format will be available to us. In the meantime, Bettina will distribute the newsletter via email until the blog function is available. The big challenge for each issue is getting content from the associations. All associations are again asked to please send content to Bettina for the newsletter.

Website

Prior to the Mexico City meeting Vilde and Marta spend a full day reviewing content and cleaning up the SPA website. Much progress was made but the work is still not finished. See the progress here: <https://www.ica.org/en/section-of-professional-associations-spa>.

Archives in 2030

On our business plan is also a project for the further future and about innovation. We think, it is better to have our own ideas and to be active and innovative instead of reacting. And we are convinced that our professions are radically changing these days so that is important to have good ideas to keep up with our professional aims and standards.

New business

Joan explained about a Catalonian project to expand transparency in records management. There is no one to evaluate the connection between information published on web portals and the original sources. A 50-page white paper was recently published by the Catalonian archives association which gives 36 indicators to evaluate whether an organization or government is being transparent. It focuses on government records but is based on international standards. So it can be applicable to other organizations. Joan and his colleague Vincenç gave a paper on this subject at the Mexico City annual meeting. This might be a new topic to be added to the SPA business plan. First, we hope to get an shortened translation.

The 9th German Archives Day: On the 3rd and 4th of March 2018 the 9th German Archives Day will take place. This year's motto is „democracy and civic rights“. Several hundred archives all over Germany will open their doors and host public tours, lectures and various events to show the importance of records and archives management for society. 88th Conference for Archival professionals / 88. Deutscher Archivtag: The VdA will organize and host the 88. Deutscher Archivtag, the largest national convention for records and archives management in Europe. It will take place in Rostock from 25th till 28th of September 2018 under the slogan “Reliable, accurate and real – democracy needs archives“. Visitors can look forward to numerous scientific lectures, workshops, discussion roundtables and –for the first time- a bar camp. The „Federal Conference of Church Archives in Germany“ includes 27 archives of dioceses and the archives of the military bishop, also the AGOA, the AGAUE and the records manager of the dioceses. The “Federal Conference of Church Archives in Germany” focused in 2017 mainly on the promotion of the cooperation between the church archives and with other archives. In order to improve the professional collaboration church archivists meet in working groups for records management, online service, appraisal and practical use of KAO. Besides these working groups and regular meetings, church archivists organized a training about legal questions in the archives in 2017, a second one is planned for 2018. In September 2017, after several years of preparation, the project for the relaunch of the archival portal for church archives (www.katholische-archive.de) could be started. This project is financed by the German Conference of Bishops and should be finished after two years. The new archival portal should help also small church archives to provide structured finding aids online and improve therefore their services for users. Further, the new church portal will deliver finding aids to national and international portals for archives.

Latin America

● ALA: Commemoration of the 40th anniversary, its origins and evolution held in Mexico City in 2017. A special session was presented about the Latin American Association of ALA Archives

As part of the annual ALA / ICA conference held in Mexico City in 2017, a special session was presented about the Latin American Archives Association ALA. The Latin American Archives Association (ALA) was created on April 6, 1973, in Lima, Peru, as an entity of professional and cultural nature, non-profit, which is considered one of the most active regional branches of the International Council of Archives (ICA, for its acronym in English). Currently, the ALA is made up of 21 nations, extending to the Ibero-American sphere with the inclusion of the Philippines. For more than 40 years, the Latin American archives associated with ALA break the isolation, integrate, assimilate and transform theories and techniques; ideas and processes; but they also recreate and contribute concepts and methods; experiences and innovations in the field of archives. They join efforts, apply international best practices to optimize archival processes of defense, organization, custody and dissemination of archives, both administrative and historical. It is an interdisciplinary action in which archivists, historians, administrators, economists and academics in general have participated, who in different conferences and seminars have shared their knowledge, analyzing methodological proposals, with the aim of making Ibero-American archives true centers of excellence, the administration, in the fight against corruption and making the best decisions based on reliable and truthful information in the achievement of peace. In recent years there has been an accelerated growth in the overall development of the archival activity of the Ibero-American community, thanks to effective collaboration among members, where the ALA plays a leading role in the organization of events that encourage the acquisition of new knowledge, as well as the exchange of ideas and experiences.

ALA: Conmemoración del 40 aniversario, sus orígenes y evolución

Como parte de la conferencia anual ALA/ICA desarrollada en Ciudad de México en 2017 se presentó una sesión especial sobre la Asociación Latinoamericana de Archivos ALA. La Asociación Latinoamericana de Archivos (ALA) fue creada el 6 de abril de 1973, en Lima, Perú, como una entidad de carácter profesional y cultural, sin ánimo de lucro, a la cual se le considera una de las ramas regionales más activas del Consejo Internacional de Archivos (ICA, por sus siglas en inglés). Actualmente, la ALA está integrada por 21 naciones, extendiéndose al ámbito iberoamericano con la inclusión de Filipinas. Desde hace más de 40 años, los archivos iberoamericanos asociados en ALA rompen el aislamiento, se integran, asimilan y transforman teorías y técnicas; ideas y procesos; pero también recrean y aportan conceptos y métodos; experiencias e innovaciones en el campo de los archivos. Unen esfuerzos, aplican las mejores prácticas internacionales para optimizar los procesos archivísticos de defensa, organización, custodia y difusión de los archivos, tanto administrativos como históricos. Se trata de una acción interdisciplinaria en la que han participado archivistas, historiadores, administradores, economistas y académicos en general, quienes en diferentes congresos y seminarios han compartido sus conocimientos, analizando propuestas metodológicas, con el ánimo de hacer de los archivos iberoamericanos verdaderos centros de excelencia, la administración, en la lucha contra la corrupción y la toma de las mejores decisiones fundamentadas en información fidedigna y veraz en el logro de la paz. En los últimos años se ha manifestado un crecimiento acelerado en el desarrollo integral de la actividad archivística de la comunidad Iberoamericana, gracias a la efectiva colaboración entre los miembros, donde la ALA cumple un papel preponderante en la organización de eventos que permiten incentivar la adquisición de nuevos conocimientos, así como el intercambio de ideas y experiencias.

The IX Latin American Meeting of Librarians, Archivists and Museologists IX EBAM took place in Mexico City from September 9 to 13, 2017, taking place at the National Numismatic Museum of the Mexican Mint, counting in the opening ceremony with the presence by Luis Oporto Ordoñez, founder of EBAM, Leonardo López, General Coordinator of the IX EBAM 2017. María Nelly Gómez, member of the Standing Committee, the deputy director of the headquarters Museum, Ángel Valtierra and the director of the National Library of Anthropology and History of Mexico, Baltazar Brito. This important professional meeting of a multidisciplinary nature in relation to documentary and heritage sciences, included lectures, general presentations, special presentations, book presentations and posters. Among the keynote lectures were "The last victory of the frigate Mercedes: public administration at the service of historical heritage", by Braulio Vázquez Campos of the General Archive of the Indies, Seville, Spain and "Revaluing heritage in the digital era", by Bolfy Efraín Cottom Ulín, from the Directorate of Historical Studies, National Institute of Anthropology and History, Mexico. The presentation of papers was distributed in 10 tables that dealt with topics related to archives, libraries, museums at the service of society, manuscripts, preservation, digitalization, library challenges, professional training, collective memory, bibliometrics, among others. Likewise, ABAMP- Peru, the national branch of the EBAM, was announced during the presentations. Presentations of books and magazines were developed. The exhibition of posters with interesting graphic samples on subjects of the disciplines pertinent to the event came from participants from Argentina, Brazil, Colombia, Costa Rica, Mexico and Puerto Rico, institutional visits were also developed, + special visits to the General Archive of the Nation, the Historical Archive of Mexico City and Chapultepec Castle. As in all EBAM, the meeting of the Standing Committee was held, which is made up of the Founding Members and the General Coordinators of each EBAM, as well as by the National Coordinators of the participating countries. Participants from Argentina, Belize, Bolivia, Brazil, Chile, Colombia, Costa Rica, Spain, Peru, Puerto Rico and Mexico attended the IX EBAM in 2017. The headquarters assigned to the X EBAM is the city of La Paz (Bolivia), from September 10 to 14, 2018, on the occasion of the celebration of the tenth meeting

that was born just ten years ago in that city. Subsequent meetings will be held in Puerto Rico (2019) and in Brazil (2020).

Este importante encuentro profesional de carácter multidisciplinario en lo referente a las ciencias documentales y patrimoniales, contempló conferencias magistrales, ponencias generales, ponencias especiales, presentaciones de libros y exposición de carteles. ● **XII CONGRESS OF ARCHIVOLOGY OF MERCOSUR was held from September 26 to 29, 2017 in the city of Córdoba, Argentina**

The XII Mercosur Archivology Congress was held from September 26 to 29, 2017 in the city of Córdoba, Argentina, and its central theme is "Archives and Archives in the Knowledge Society, with the participation of 600 attendees from Bolivia, Brazil, Chile, Colombia, Ecuador, Israel, Mexico, Paraguay, Peru, Switzerland, Uruguay and Argentina as host country. The inaugural lecture was given by Dr. Silvia Schenkolewski with the theme "Archives and archivists in contemporary society - Realities and challenges". This successful congress was organized by the Network of Graduate Archivists of Córdoba with the support of the National University of Córdoba. Within the framework of the CAM, the following parallel meetings took place: VIII Meeting of Mercosur Professional Associations, highlighting the participation of Didier Grange on behalf of the International Council of Archives; the VIII Meeting of the Ibero-American Network of University Archival Teaching, highlighting the presence of Dr. Mercedes de Vega Armijo, President of the Latin American Association of Archives (ALA); the III Encounter of Photographic Archives of the Mercosur; the I Meeting of Personal Archives, the First Meeting of Archival Editorials; the IX Meeting of Municipal Archives; the VIII Meeting of University Archives; the XVII Meeting of Students of Archivology and the

Meeting of Archivists without Borders. The thematic areas covered access to information, new technologies, archival training, the dissemination of archives and international cooperation, archival techniques, the social role of the archivist. There were also technical visits, specialized courses, workshops, presentation of books by author and exhibition of scientific posters. Prior to the congress, the meeting of the CAM Advisory Council, made up of the General Coordinators of each congress, was held. Among the conclusions of that meeting, it is worth mentioning that, by decision of the Council, the congress will continue with its denomination of origin, the Archivology Congress of the Mercosur, whose objective is to promote union and professional exchange among the archives of the Common Market of the South considering that the denomination does not prevent or limit the participation of professionals from anywhere in the world but that the organization must be in charge of a member country of the Mercosur, also resolved to include as a side event in the next CAM, the Day of Archives of human rights. With regard to the Meeting of Professional Associations, it was proposed to create a Network of Associations of Archivists of Latin America open to Associations. Finally on the closing day, Gabriel Queijo on behalf of the Association of the Uruguayan Association of Archivists presented as headquarters of the XIII CAM in 2019 to the city of Montevideo, For more information consult: <http://redarchiveroscordoba.com/editorial/xii-cam/>

Norway

• Norwegian Society of Records Managers and Archivists (Norsk Arkivråd/NA)

2017 has been a busy year for us. As always, it is important to us to arrange a great variety of courses and trainings within the profession in order to strengthen and enhance the knowledge of our members. We strive to continuously develop our course portfolio to keep current and provide the best education possible in a rapidly changing records management environment. For 2018, we have planned to develop a few new courses and also workshops to meet new demands both from our members and the society as a whole. For instance, digitalization requires records managers to be able to work in different ways and cooperate in a more integrated way with the rest of the organization, and we wish to establish meeting places where these skills can be developed and experiences shared.

We have arranged two larger seminars in 2017; in the spring and in the autumn. In these yearly seminars we aim to focus on the most current issues in the profession and the challenges and opportunities we meet. In the autumn seminar, subjects such as robotics, GDPR and the new archive regulation were hot topics that provided interesting discussions.

2017 has been a particularly important year when it comes to the Norwegian archive regulations, and we have responded to public hearings regarding various parts of these earlier this year. A committee has been formed to review the archive law, a review that we have advocated. We are currently holding meetings all around Norway in our region chapters, in order to deliver our very best feedback and suggestions to this committee. It is important to us that the whole organization be instrumental in this very important work.

NA also participated in hearings in the most relevant committees of the Parliament regarding the national budget for 2018, which is a good opportunity to lobby for our issues and raise awareness about the importance of records management and archives.

2018 will be an even more active year, as we have several activities planned and have recently received funds that will provide us with ample possibilities to put them in to life.

Poland

- [The 7th General Congress of Polish Archivists](#)

The 7th General Congress of Polish Archivists co-organized by the Association of Polish Archivists and the Head Office of the State Archives took place in Kielce from 20 to 22 September 2017. The central theme of the Congress was “Archival science without frontiers” The Congress was followed by exhibitions and professional workshops. The Congress gathered over 700 archivists, record managers, scientists, and digitisation specialists from Poland, Argentina, Austria, Czech Republic, France, Hungary, Lithuania, the Netherlands, Russia, and Ukraine who could share their experiences and opinions and discuss the papers presented by over 100 speakers.

Particular panels i.a. were focused on digitization, record management, electronic documents, archival education, community archives or the future of archival science in Poland. Some panels heated lively discussions, especially those concerned planned changes in archival law or archival methodology. The central theme of the Congress reflected panel “Poles in archives without frontiers” during which Polish archivist who succeed in foreign archives could present their institution, workflow and archival science in their countries. Panel organised by the Institute of National Remembrance brought closer problems with personal data protection in documents of former state security bodies. Participants could also gain an insight into problems of church and family archivists.

6 Reports from ICA Expert Groups

Highlights from the Human Rights Working Group

2017 has been both a good and a terrible year for the Human Rights Working Group (HRWG): we lost one of our most active members, Cristina Bianchi (1957-2017), while we were still mourning the loss of another most brilliant member, Sigrid McCausland (1953-2016). But during the past year we could also celebrate some important achievements, our membership is increasing (the HRWG currently counts members from 17 countries in North and South America, Africa and Europe) and we are full of projects for the future.

In 2017, first the Society of American Archivists (SAA), then the Latin American Archival Association (ALA) endorsed the *Basic Principles on the Role of Archivists and Records Managers in Support of Human Rights*, and other associations are currently considering their adoption. Maybe, not all of the SPA members remember that, in 2011, it was the SPA that suggested the HRWG to draft a set of principles on the role of archivists in the protection of human rights. The HRWG welcomed this suggestion and is still very grateful to the SPA for its encouragement to start this undertaking. After lengthy discussion and consultations within the ICA, drafting and redrafting, in 2016 the Program Commission endorsed the *Basic Principles* "as a working document" for discussion, publishing and use by archivists. We very much encourage archival associations to translate the *Basic Principles* in their own languages (they are currently available in English, French, Spanish, Chinese, Japanese, Portuguese, Korean and Serbian) and to adopt them. As HRWG, we are ready to cooperate with archival associations, if they want to organize seminars or other initiatives on the *Basic Principles*. Every month, the HRWG publishes a newsletter, written and compiled by Trudy Huskamp Peterson. Each issue is a trove a pieces of news that concern the intersections between records and archives and human rights. The newsletter is distributed through the ICA mailing list and is posted for free download on the ICA website in three languages (English, French and Spanish). We encourage archival associations to further circulate the newsletter among their members.

At the ICA Conference in Mexico, the HRWG organized a panel ("Principles and practices: everyday challenges and the Basic Principles on the Role of Archivists and Records Managers in Support of Human Rights") and a two-day workshop on "Human Rights and Archives in Latin America". A total of thirty archivists from sixteen different countries (from Europe, Asia, North, Central and South America) participated in the workshop.

We are particularly proud to inform SPA members that, for the first time ever, two members of the HRWG were admitted to give a snapshot presentation at the UN Forum on Business and Human Rights (Geneva, Switzerland, 27 November 2017). One of the main field of interest of the HRWG is

the role that business archives can provide for the protection of human rights. A HRWG's subgroup prepared a "Statement on business archives and human rights" that highlights how the *UN Principles on Business and Human Rights* (also known as "Ruggie Principles") cannot be enforced without archives.

HRWG members are participating in an expert group on "safe havens for archives at risk" organized by the NGO Swisspeace. The group is defining criteria for trustworthy safe havens, identifying standards that could be useful for save haven solutions, and discussing the establishment of a central information point for safe havens for archives at risk. War, political unrests, civil conflicts have always put archives at risk; moreover, currently climate change is creating dramatic risks for the archives of some small island states. As HRWG, we feel committed to contributing to the preservation of archives at risk.

The HRWG is currently committed also on other fronts, such as – for example – producing an academic model curriculum on "archives and human rights". We seek the collaboration of other ICA bodies and we will be happy to collaborate with archival associations who intend to promote, among their members, awareness on the relevance of public and private archives for the protection of human rights.
